## Reading's Biggest Ever Road Repair Programme

At the end of 2019 residents were given the opportunity to participate in a consultation on Reading Borough Council's 2020/21 budget. In the introduction to the consultation RBC's Labour Leader Jason Brock stated: "I know you think road surfaces are in a poor condition. This budget is proposing Reading's biggest ever road repair programme with £9million on new road surfaces, prioritising residential streets."

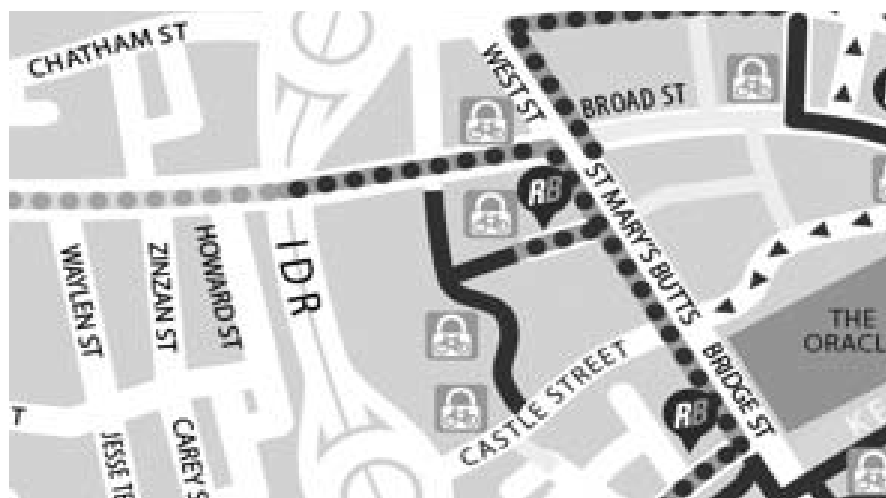
In summarising the responses to this consultation RBC concluded: "In terms of sustainable transport options, the results confirm that more needs to be done to support people who want to switch to using the bus or to start cycling or walking."

In mid-March RBC released two lists of roads that would be resurfaced in the next 3 years. The heralded £9million splurge is being spent on 523 minor and residential roads, with just £0.8m on 51 sections of major roads (i.e. the town's A roads and B roads).

Reading's official cycle network comprises the 13 branded routes shown in the Council's Cycling in Reading map. The good news is that the roads listed for resurfacing do cover various parts of Reading's cycle network. The bad news is that some of the worst roads on the cycle network are inexplicably missing from the list.

So whilst several cul-de-sacs with perhaps a dozen houses will be treated, the town end of Oxford Road and St Mary's Butts - perhaps the worst

road surfaces in Reading Borough and a key route for cyclists - are ignored. Whilst the various Crescents, Closes, Mews and Gardens dotted around Reading will be resurfaced, Whiteknights Road, part of Cycle Route R20 and peppered with potholes which being less than 5cm deep do not warrant repair, is left to deteriorate.

Our view is that a road repair programme is long overdue, but it should prioritise those road users most affected by the Reading's potholed and rutted roads. It should prioritise those roads where a decent road surface would encourage sustainable travel. With this in mind we launched an on-line petition at the end

of February calling on RBC to prioritise road repairs on those roads which make up its designated and branded cycle network. Thanks to all our supporters who signed.

To follow this up Reading Cycle Campaign was due to speak at the Council's Strategic Environment Planning and Transport Committee, at which the proposed road repair programme was to be approved. However, just minutes before our plea to fully consider the cycle network could be presented, all Council meetings were cancelled in the wake of Covid-19. Instead we have written to the Lead Councillor for Strategic Environment, Planning and

Transport requesting that those parts of the cycle network that are in poor condition are not overlooked by the road repair programme.

So perhaps now is a good time to highlight Cycling UK's advice on what you should do if you hit a pothole. This lists 10 steps to help keep you safe and maximise your chances of successfully claiming compensation, including advice on gathering evidence and instructing a solicitor: [www.cyclinguk.org/what-should-i-do-if-i-hit-pothole](http://www.cyclinguk.org/what-should-i-do-if-i-hit-pothole).

### Spring Report 2020

The Cycle Forum on 4th December focused mainly on the LCWIP (Local Cycling and Walking Infrastructure Plan) that the Council have now submitted in draft form to the DfT for funding.

This plan, if funded and implemented, would make substantial improvements for cycling and walking over the next 10 years with a number of new routes. The plans are in their draft stages, and the difficult part comes with how to

provide good quality cycling routes in the places where they are needed.

With the Council's continued failure to provide adequate and legally necessary signing in the town centre, to show where cyclists can legally ride, their ability or willingness to provide good routes for cyclists in the LCWIP seems questionable!

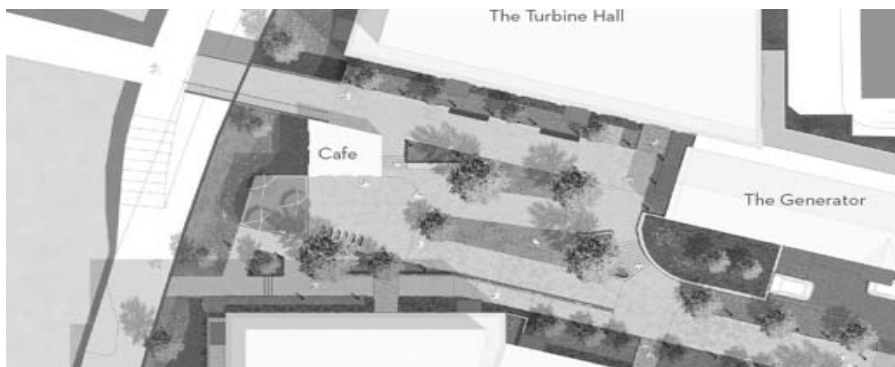
Work on NCN route 422 is nearly complete with new cycle lane markings on Berkeley Avenue and Wokingham Road. Apparently changes to reduce parking, and facilitate better cycling facilities, on Wokingham Road were dropped because of numerous objections from a local church. Surely there must be some scope for further cycling improvements there.

The Campaign has also been involved with the Council's CAST (Cleaner Air and Safer Transport) forum, with representatives and individuals from a variety of interests when we attended the second meeting on 29th January. Hopefully this forum will help push the Council into improvements for cyclists and pedestrians, and not just buses! No-car zones outside selected schools is hoped to be one measure which will be developed.

## Christchurch Bridge To Get Hairpin Bends?

Berkeley Homes has now submitted its planning application for blocks of flats on Vastern Road. Importantly for cyclists this development includes for a new link from the cycle/pedestrian bridge over the Thames to Vastern Road and the town centre.

This is a once-only opportunity to make a good quality cycle link from north Reading to the town centre, but Berkeley has proposed a ramp with two 180 degree switchbacks, one of which is the milling around area in front of a café. We don't think this is great.

## Wokingham Road - New Cycle Lanes

RBC has recently repainted the cycle lanes along Wokingham Road. This was done as part of the works to create National Cycle Route 422, which runs between Newbury and Windsor and crosses through Reading along Bath Road, Berkeley Avenue, Cemetery Junction and Wokingham Road.

The creation of NCN422 has afforded the opportunity to right some previous wrongs, and it is encouraging that the Council is starting to take account of national guidance when creating cycle infrastructure.

The infamous car door danger zone cycle lanes have now been replaced with wider

lanes that include a buffer strip between the cycle lane and the parking bays - see the 'before' and 'after' photos above.

This increase in width has meant that there is now only a cycle lane on one side of the road (Wokingham bound). To achieve a proper cycle lane on both sides of the road would have meant sacrificing some parking bays. However, it is better to have one proper cycle lane than two dangerous ones.

There are now also mandatory cycle lanes on both sides of Wokingham Road on the gradient section south of the run of shops. A mandatory cycle lane has a solid white line, which should not be crossed by motor vehicles (see below).



Close to the borough boundary, near The Three Tuns pub, the outbound cycle lane ends with a very large turn left sign (see below).

# Cycling Challenge for Scientists' Tribute

## Why not take on your next cycling challenge!!

A recent Sports England Active Lives survey showed that 6.3 million adults cycle for leisure and sport, which unsurprisingly resonates with the fact that cycling is becoming one of the fastest growing sports.

For some this brings desire to push the limits of one's endurance and cycle ever further distances, for which the world of Audax offers an arena. This was the excitement that took hold of me after my first longer ride....

An Audax ride, also known as a Randonnée, is a long-distance cycle ride that must be completed within a set time limit, including any stops, whilst maintaining a minimum and maximum speeds.

It is not a race, requiring riders to be self-sufficient and passing




through control points to ensure the feat is completed as intended.


Audax distances start from 50km, as an introduction to long-distance cycling completed in a matter of hours and move upwards all the way to 1000km taking several days to complete!

A brand new Audax event is coming to Reading on 25th April 2020, organized by myself on behalf of Cycling UK Reading. The Audax theme will be as tributes to notable UK Science Pioneers.

charity and will be shared between Thames Valley Air Ambulance and Launchpad Reading.

There are three rides on offer: 50, 100 and 200km.

'A Tribute to Alan Turing' is a 200km ride via Bletchley Park as a tribute to Alan Turing, the WWII codebreaker and widely credited as the father of Theoretical Computer Science and Artificial Intelligence.

'A Tribute to Robert Boyle' is a 100km ride via Oxford University labs as a tribute to Robert Boyle, the Father of Modern Chemistry, discoverer of Boyle's Gas Law and co-founder of the Royal Society.

The route passes around the site in Oxford where Robert lived between 1655-1668 when he discovered Boyle's Law.

And finally, 'A Tribute to Johnson and Matthey' is a 50km ride paying tribute to Percival Johnson and George Matthey, the 19th Century

metallurgy pioneers of Platinum Group Metals and founders of the FTSE100 global chemicals company Johnson Matthey plc.

This ride is quite scenic, mostly on quiet roads and country lanes exploring the foothills of beautiful Chilterns (AONB) and returning via Johnson Matthey Technology Centre at Sonning Common.

All rides start and finish at Our Lady and St Anne's Church in Caversham, which will also serve as the event control.

Entry fee for all events is ONLY £10, which includes breakfast at start and food after the finish!

# Cyclists at Roadworks, New TfL Guidance

Guidance for Local Authorities and their contractors has been limited to the Highways Agency Traffic Advisory Leaflet (TAL) 15/99 Cyclists at Roadworks, produced in 1999.

Transport for London has now prepared alternative guidance available from <http://content.tfl.gov.uk/temporary-traffic-management-handbook.pdf>.

It was initiated and specifically produced to include clearer and better provision for cyclists and pedestrians than in the TAL 15/99.

It includes a 44-page chapter on Cyclists at Roadworks giving a range of guidance on signing, lane widths and alternative road layouts and cycling provision.

As well as the infamous 'Cyclists Dismount and Use Footway', there are a number of other suggested signs which may be relevant, including:

- No Entry Except Cyclists
- Road Closed Except Cyclists
- Narrow Lanes Do Not Overtake Cyclists
- Cycle Lane Ahead Closed

The road layout examples given are largely those actually used by TfL in the preparation of the document,

and include: single and dual carriageways, cycle tracks, temporary shared-use paths as well as at road junctions.

The TfL document should be accepted by all Highway Authorities as best practice, with any contracts and agreements specifically referring to it.

RCC has already asked RBC to adopt the TfL best practice guidance and

hope they will take this simple measure to improve conditions for cyclists.

If you spot any roadworks where cyclists have not been adequately catered for, then check the TfL document for possible solutions and contact your councillors or the Council.
